Notice is hereby given by the Board of Commissioners of Cedar River Water & Sewer District of King County, Washington that the District is updating its Small Works Contractors and Vendor Rosters pursuant to RCW 57.08.050.

The District occasionally requires the services of responsible contractors to make minor repairs, additions, and improvements to the District's water / sewer system. All contractors interested in being included upon the District's Small Work Roster should submit an application (using the District's application form) to the District at the following address:

Members of the Roster must be financially able to undertake and complete small works contract, the estimated cost of which exceed \$5,000, but are less than \$200,000, such projects are not required to be publicly advertised for bid.

The District also invites proposals from vendors of supplies, materials, and equipment that wish to have their names and qualifications added to the District's Vendor Roster for purchases between \$5,000 and \$50,000.
