II. NEW INSTALLATION CHARGES

Partial Water Meter Installations (service stub at property) - Charged a flat fee per chart below for up to and including 2" meters unless actual costs of installation exceed 115% of the fee, in which case the difference will be due in addition. Meters larger than 2" will be charged based on actual costs of installation with the same deposit requirements as complete meter installations.

Complete Water Meter Installations – Charges are based on actual costs of installation with a deposit required per chart below. Credit balances remaining will be refunded to the customer and excess amounts owing will be billed to the customer.

Actual costs of partial and complete meter installations mean all costs as defined in Section 6.13 of the District's Policy Manual. Charges for District labor and equipment shall be based on hourly rates as set forth in Schedule 1 attached.

REWARD

The first two customers to report tips leading to a positive identification of persons participating in an unauthorized connection to or unauthorized use of the District water system will receive \$100.00 each. This reward shall apply to unauthorized use of, or connection to, meters, setters and fire hydrants. Only persons who have not participated in the unauthorized use may claim a reward.

Exceptions: First two customers may not be related. Employees of Cedar River Water and Sewer District and their family members are not eligible for a reward.

The fees listed in this document will supersede all previous rate schedules and resolutions. This will serve as the master list for all fees and penalties charged by the District. This list may be amended, in whole or in part, without notice by resolution of the Board of Commissioners.

FOOTNOTES

¹ Such charges shall be automatically increased annually by rate of interest charged to ULID No. 23 assessments. (Interest has accrued for 10 years, no further interest to accrue.)

² The acreage charge only applies to single family residential development in non-urban areas (the front

footage charge applies otherwise). A minimum charge of 3 acres (for parcels of that size and above), up to a maximum charge of 5 acres, shall be charged for one single family residence. Additional acreage charges for any unpaid acreage shall be due upon construction of each ADU based on the formula in the preceding sentence. Acreage charges for any remaining unpaid acreage shall be due upon non-single family residential development or upon subdivision of the parcel. Acreage charges generally do not apply when owners install on-site mains pursuant to District's developer extension standards.

³ A minimum charge of 75 front feet for water and 100 front feet for sewer shall apply; front footage is measured by the footage that a main traverses a parcel; front footage charges apply to all development, except when acreage charges apply.

⁴ Number of ERU charges to be determined by estimated water use if available, by using the formula that 1 ERU = 80,300 gallons of water per year. If estimated water use not available, then the Meter Size / ERU Equivalent Chart on Page 8 will be used.

⁵ To be increased by 5.0% interest annually for a period of 10 years. (Interest has accrued for 10 years, no further interest to accrue.)

⁸ ERUs attributable to Commercial Property shall be determined by dividing the total number of square feet of improvements by 2,000. Fractions shall be rounded up to the next whole number.

⁹ Acreage and Front Footage charges as stated above will apply unless the District has specifically adopted another unit of measurement for a project specific charge.

¹⁰ These rates are based on the regular water rates, plus surcharges adopted by resolution #4201. These rates only apply to the Webster Lake Communities as defined in said resolution.

¹² This charge applies to all parcels shown on the map attached to Resolution 07-19. To be increased by 5.0% interest annually for a period of 10 years. (Interest has accrued for 10 years, no further interest to accrue.)

¹³ To be increased by 5.0% interest annually for a period of 10 years (Interest has accrued for 10 years, no further interest to accrue.)

¹⁴ Rate subject to change based upon District policy manual and most recent Bond issues. See Section 6.15 of the District's Policy Manual. When other interest rates have been adopted for specific situations, those rates shall apply.

¹⁵ To be increased by 5.0% interest annually for a period of 10 years (Interest has accrued for 10 years, no further interest to accrue.)

¹⁶ Fee for scanning documents requested through public records request. Fee will apply if 10 or more pages are scanned.

¹⁷ Rate may not exceed maximum of prime plus 4% as stated in RCW 57.08.081(3).

¹⁸ To be increased by 4.0% interest annually for a period of 10 years. (Interest has accrued for 10 years, no further interest to accrue.)

¹⁹ Costs and fees billed by the attorney shall be added to the customer account as incurred. The foreclosure process may include steps by the attorney to analyze, research the condition of title and settle the account prior to actual filing with the court. These costs are still considered part of the foreclosure process.

²⁰ Credit card payments will be charged the administrative fee charged by the processor (currently \$3.95 per online transaction & \$4.70 per IVR (phone) transaction).

²¹ Common areas used by tenants and staff are considered an extension of the living units and are

therefore included in the per unit connection charge. Commercial and/or retail areas open to the general public are subject to commercial/non-residential connection charges.

²² Multi-Family is defined as Apartments, Condominiums, Townhomes, Duplexes (single meter), Multiplexes and Assisted Living Facilities.

²³ Accessory Dwelling Units (ADU's) constructed after October 1, 2019, if separately chargeable per District policy, will be charged a General Facilities Charge equal to 50% of one ERU. For ADU's constructed prior to October 1, 2019, that have not previously paid a General Facilities Charge, the District will assess the General Facilities Charge applicable at the time of the ADU's construction.

²⁴ Reduced General Facilities Charge only applies to mobile homes within a mobile home park or development.

²⁵ Disconnect Fee applies to non-payment, customer requested lock off or irrigation system lock off.

²⁶ "Residential, Irrigation" includes single-family residential and dedicated irrigation accounts.
